## PROCEEDINGS OF 15<sup>TH</sup> MEETING OF THE STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA)

### Opening Remarks:

The 15<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held in Department of Environment, Science & Technology, Shimla on 21<sup>st</sup> May, 2013 for consideration of cases for grant of Environment Clearance, approval of Terms of References and change of address of the project proposals as per the recommendations made by the State Level Environment Appraisal Committee (SEAC) in its 19<sup>th</sup>, 22<sup>nd</sup>, 23<sup>rd</sup>, 24<sup>th</sup>, 25<sup>th</sup>, 26<sup>th</sup> and 27<sup>th</sup> meetings.

The Member Secretary, SEIAA, welcomed the Chairperson and the Member of the Authority. The proceedings were started with the permission of Chair and following deliberations were held and decision taken:

### Item No. 1

The Proposal involves Extraction of Stone for the Stone Crushing Unit over an area of 298.03 Kanals at Khasra Nos 1614/1604, 1615/1604, 1616/1604 & 1557/1389, at Mohal Tika Mundkhar Gainda, Mauza Mehmeta, Tehsil Bhoranj, Dist. Hamirpur H.P with Stone extraction capacity is 56500 TPA. As per the

prescribed ToRs the proponent submitted EIA/EMP after including the issues raised in the Environmental public hearing held on 27-08-2012. The EIA/ EMP submitted by the proponent was appraised and the proposal was recommended to SEIAA for grant of Environment Clearance by the SEAC.

The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

The SEIAA after detailed deliberations approved the proposal for grant of Environment Clearance. The SEIAA observed that the proponent shall also comply with following conditions in addition to the conditions already imposed by the SEAC:

**The Proposal of M/s Himachal Stone Crusher for Extraction of Stone from the Quarry for the Stone Crushing Unit VPO, Mundkar, Tehsil Bhoranj, Distt. Hamirpur, HP was considered and approved for grant of Environmental Clearance with the conditions recommended by the SEAC. In addition the proponent shall submit an affidavit to the Member Secretary SEIAA to the effect that the mining was allowed by the Industries Department in an area less than 5 hectares before orders dated 27-02-2012 were passed by the Hon'ble Supreme Court and thereafter, the operation of crusher was allowed by the Mining Department only on the available stock and no mining activity was undertaken after 27-02-2012. The Proponent shall also submit supporting documents of Industries/ Mining Department, thereafter the Member Secretary SEIAA will issue the Environmental Clearance.**

**2.2 M/s Jagdamba Stone Crusher, Village & PO. Deonda, Tehsil Kandaghat Distt. Solan HP.**

The Proposal involves for Extraction of Stone for the Stone Crushing Unit over an area of 7-14 Bighas private land in Khasra Nos. 728/623, 729/623 and 730/623 at Mauza & Mohal-Deona, Tehsil-Kandaghat Distt-Solan H.P with Stone extraction capacity is 200 MT/week. The EIA/ EMP submitted by the proponent was appraised and the proposal was recommended to SEIAA for grant of Environment Clearance by the SEAC.

The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

The SEIAA after detailed deliberations considered and approved the proposal for grant of Environment Clearance.

**The Proposal of M/s Jagdamba Stone Crusher, Village & PO. Deonda, Tehsil Kandaghat Distt. Solan HP was considered and approved for grant of Environmental Clearance with the conditions recommended by the SEAC in addition to the general conditions.**





**2.3 M/s Sheetal Stone Crusher, Village Dhadhoon, PO. Pansai, Tehsil Nadaun, Distt. Hamirpur HP.**

The proposal is for extraction of boulder, sand and bajri for the Stone Crushing Unit over an area of 6-29-34 Hectares (private land) in Khasra No. 233, 64 and 317 at Mauza-Hathol, Mohal-Dadhoon, Tehsil-Nadaun, Distt-Hamirpur, and H.P with Stone extraction capacity is 30,000 MT/Annum were fixed by EAC, MOEF, GoI vide letter dated 28<sup>th</sup> April, 2011 as at that time SEIAA/SEAC was not constituted. As per the prescribed ToRs the proponent submitted EIA/EMP after including the issues raised in the Environmental public hearing held on 06-01-2012.

The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

**The Proposal of M/s Sheetal Stone Crusher, Village Dhadhoon, PO. Pansai, Tehsil Nadaun, Distt. Hamirpur HP was deliberated and it was decided that the credible action for past violation shall be taken in accordance with the office memorandum dated 12-12-2012 and report is submitted to the authority by the Proponent. Thereafter the case will be dealt with and processed as per the prescribed procedure for the Environmental Clearance as per recommendations of SEAC/ decision taken by the State Government as per the merit of the case.**

**2.4 M/s Sanjay Chauhan, Stone Crusher, at Tika-Dhamrol, Mauja-Mewa, Tehsil Bhoranj, Distt. Hamirpur HP.**

The Proposal is for Extraction of Boulder, Sand and Bajri for the Stone Crushing Unit over an area of 39-12 Kanals (private land) in Khasra No. 1512 and 1514 at Tika- Dhamrol, Mauza- Mewa, Tehsil- Bhoranj, Distt-Hamirpur, H.P with Stone extraction capacity is 14610 MT/Annum.


The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

The Proposal is for Extraction of Stone for the Stone Crushing Unit over an area of 11-11-14 Bighas (private land) in Khasra No. 546,547,563,564,565 at Mauza-Bagla, Mohal-Brabhal, Tehsil-Sadar, Distt-Mandi H.P. with Stone extraction capacity is 106200 TPA maximum.





The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

The SEIAA after detailed deliberations approved the proposal for grant of Environment Clearance.

**The Proposal of M/s Akhter Stone Crusher, (Prop. Mohd Soyab Akhter), Village Dadoh, Tehsil Sundernagar, Distt. Mandi (HP) at Bagla, Mohal Brabal, Tehsil Sadar, Distt. Mandi (HP) was considered and approved for grant of Environmental Clearance with the conditions recommended by the SEAC.**

**2.6 M/s Thakur Enterprises, Village Bairyan, P.O. Bhaloun, Tehsil Bangana, Distt. Una HP.**

The Proposal is for Extraction of Sand, Stone and Bajri for the Stone Crushing Unit over an area of 9-35-30 Hectares at Khasra Nos 967 & 969, Mauza-Chowki Minar, Mohal- Baduhi, Tehsil- Bangana Distt-Una with Stone extraction capacity is 54000 TPA were fixed. As per the prescribed ToRs the proponent submitted EIA/EMP after including the issues raised in the Environmental public hearing held on 08-2012.

The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

Una HP was considered and approved for grant of Environmental Clearance with the conditions recommended by the SEAC. The Proponent shall also submit supporting documents of Industries/ Mining Department, thereafter the Member Secretary SEIAA will issue the Environmental Clearance.**

**2.7 M/s Gupta Property Developer (P) Ltd., Village Judi Kalan-Baddi, Distt. Solan HP.**

The Project Proposal with a total cost of Rs. 25.7 Crores involves Construction of Housing and commercial project at Village- Judi Kalan, Tehsil Baddi, Distt-Solan H.P. The total project land area involved is 10875 square metres and total built up area 25125.219 square metres out of which built up area is 20828.539 square metres, car parking area is 1236.93 square metres and area under road & pavement is 3059.75 square meters. The proponent has submitted copies of approved plans by BBND. The total water requirement for the proposed project is 120 KLD which shall be met from bore wells. The power requirement for the Project is indicated as 850 KW sourced through H.P.S.E.B. DG set of 240 KVA has been proposed. The unit has proposed STP of 100 KLD for sewage treatment. The unit has proposed Rain Water Harvesting System of capacity 500 KL. Solid waste to be collected/ disposed off as per provisions of



Municipal Solid Waste (Management & Handling) Rules, 2000 under Environment (Protection) Act, 1986. Biodegradable waste shall be used for vermin-composting and Bio-Gas and non biodegradable waste shall be handed over to PWD for road construction as proposed.

The proposal was also listed in the 23<sup>rd</sup> SEAC meeting and proponent was asked to submit information on observations made. Now the unit has attended to the observation made in 23<sup>rd</sup> meeting and also submitted letter of H.P. State Pollution Control Board No. 3206-07 dated 22-03-2013 informing that project proponent has not started any construction work.

The project proponents made presentation before the SEIAA with respect to their project proposal and environment and pollution control aspects, and the issues raised by the SEAC.

The SEIAA after detailed deliberations approved the proposal for grant of Environment Clearance.

**The Proposal of M/s Gupta Property Developer (P) Ltd., Village Judi Kalan-Baddi, Distt. Solan HP was considered and approved by SEIAA for grant of Environmental Clearance with the conditions recommended by the SEAC besides the general conditions.**
