**PROCEEDINGS OF 27<sup>th</sup> MEETING OF SEIAA, HIMACHAL PRADESH, HELD UNDER THE CHAIRPERSONSHIP OF SH. S.S. PARMAR, IAS (RETD.) IN THE CONFERENCE HALL OF DEPARTMENT OF ENVIRONMENT, SCI. & TECH., PARYAVARAN BHAWAN, SHIMLA-1 ON 10<sup>TH</sup> JUNE 2016 AT 11:30 AM.**

At the outset, the Member Secretary (HPSEIAA) extended warm welcome to Sh. S.S. Parmar, IAS (Retd.), Chairman, HPSEIAA. With the permission of the Chair, following agenda items were discussed:

### **ITEM NO. 1:**

Confirmation of the Minutes of the 26<sup>th</sup> Meeting of the SEIAA held on 29<sup>th</sup> April & 2<sup>nd</sup> May, 2016:

All decisions of the Authority were executed. No additional comments were received; hence, Minutes of the 26<sup>th</sup> Meeting of SEIAA were confirmed by the Authority.

### **ITEM NO. 2:**

The proposal for imposing application processing fee from the applicants/ projects applying for grant of Environmental Clearance was discussed in detail. The proposal was discussed in the light of the same arrangement i.e. application processing fee in other States SEIAAs. The notification of State Government Orissa, Karnatka, Kerla, Jharkhand, Madya Pradesh, Chattishgarh were taken on record. The SEIAA also discussed the proposal with Member Secretary, HP SPCB who was invited as special invitee for the meeting in order to rationalize the proposal with existing arrangement of charging consent fee by the State Pollution Control Board.
