**NOTIFICATION**

In continuation of this department's Notification No. STE-E (4)-1/2003, dated 29-04-2003, and even number dated 10-09-2004, in exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986 as delegated to the State Government by the Government of India, Ministry of Environment and Forests, Department of Environment, Forests and Wildlife vide Notification No. S.O. 152 (E), dated 10<sup>th</sup> January, 1988 read with Section 21 of the General Clauses Act, 1897, the Governor of Himachal Pradesh is further pleased to amend the distance criteria contained in the above mentioned notification for the existing stone crushers in the State in the following manner:

For the existing Sr. No. 3 and 4 of Para 1.1 Norms, the following criteria / parameters shall be substituted as under, namely:-

Sr. No.	Criteria	Distance for Existing Stone Crushers (crow flight distance in meters)	Distance for Stone Crushers to be set up in future (crow flight distance in meters)
3.	Minimum distance from district Head Quarter	300	1500
4.	Minimum distance from Town or Notified Area Committee	300	1000
